Source Water Information

The source of our drinking water is wells that bring groundwater to the surface.

The Eastern Regional Water System receives its water from the Northwest Regional Water Treatment Plant, which serves the Beavercreek Community, and extends into Xenia Township, parts of Kettering, Sugarcreek, and Bath Townships, to serve the Career Center, Cedarville, Shawnee Lake, and Wilberforce communities. It receives water from three (3) well fields, which all draw water from the Little Miami River Buried Valley Aquifer. The well fields are located on Beaver Valley Road, Shakertown Road, and Orchard Lane.



Source Water Assessment - Well Field Susceptibility

A Source Water Assessment Report was prepared by Ohio EPA for Greene County's Northwest Regional System, which supplies water to GCSED's Eastern Regional system. The Ohio EPA has determined that the aquifer that supplies water to the Northwest Regional System has a high susceptibility to contamination. This conclusion is based on: the presence of a clay layer with variable thickness (thinnest near the North Well Field), the shallow depth of the aquifer (as shallow as 21 feet in North Well Field and 60 feet in Valley Springs Well Field), the presence of a documented contaminant plume in the uppermost aquifer, and the presence of potential significant contaminant sources near the protection area. This susceptibility means that under currently existing conditions, the likelihood of the aquifer becoming contaminated is relatively high. This likelihood can be minimized by implementing appropriate protective measures. Sources of Potential Contaminants in Drinking Water

The sources of drinking water (both tap water and bottled water) include wells, rivers, lakes, streams, ponds, reservoirs, and springs. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material. It also can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

(A) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife;

(B) Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming;

(C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses;

(D) Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems;

(E) Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the USEPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk.

Taking Special Precautions



Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS, or other immune system disorders, some elderly, and infants can be particularly at risk from infection. These people should seek advice about drinking water from their health care providers. About Your Drinking Water

The Ohio EPA requires regular sampling to ensure drinking water safety. GCSED conducted sampling during 2019. Samples were collected for a total of 199 different contaminants (bacteria, inorganics, synthetic organics, disinfection byproducts, lead and copper), most of which were not detected in our water supply. The Ohio EPA requires us to monitor some contaminants less than once per year because the concentrations of these chemicals do not change frequently. Some of our data, though accurate, are more than one year old.

Monitoring & Reporting Violations & Enforcement Actions

The 2019 Consumer Confidence Report (CCR) for Eastern Regional was found to have several deficiencies including: an indirect website link to view the entire report; a missing contact name and number to request a paper copy of the CCR; an omission of a sentence about FDA regulations that establish limits for contaminants in bottled water; and an omitted Table of Detected Contaminants for Greene County Northwest Regional (wholesaler for Greene County Eastern Regional). These oversights have been corrected in GCSED's 2020 Eastern Regional's Water Quality Report.

Definition of Terms

Maximum Contaminant Level Goal (MCLG): The level of a contaminant in the drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Contaminant Level (MCL): The highest level of contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible, using available treatment technology.

Maximum Residual Disinfectant Level (MRDL): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG): The level of drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Parts per Million (ppm) or Milligrams per Liter (mg/l): Units of measure for concentration of a contaminant. A part per million corresponds to one second in a little over 11.5 days.

Parts per Billion (ppb), or micrograms per liter (ug/l): Units of measure for concentration of a contaminant. A part per billion corresponds to one second in 31.7 years.

Picocuries per Liter (pCi/L): A common measure of radioactivity.

Action Level (AL): The concentration of a contaminant, which, if exceeded, triggers treatment or other requirements that a water system must follow.

Treatment Technique (TT): A required process to reduce the level of a contaminant in drinking water.

The < symbol: A symbol which mean less than.

NA: Not applicable.

Risk Factors Explained

The following substances are found in our water, normally at levels below the action levels. There are some risk factors that could be involved with even low levels of these substances. Some terms and abbreviations used in this section are included in the "Definition of Terms" section above.

Nitrate: Nitrate in drinking water, at levels above 10 ppm is a health risk for infants of less than six (6) months of age. High nitrate levels in drinking water can cause blue baby syndrome. High nitrate levels can also increase the risk of a particular kind of anemia in pregnant women. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. Arsenic: EPA has issued rules regarding the drinking water standard for arsenic. Arsenic is a naturally occurring mineral known to cause cancer in humans in high concentrations. EPA continues to research the health effects of low levels of arsenic. It is linked to other health effects such as skin damage and circulatory problems. Some people who drink water containing arsenic in excess of the MCL, over many years, could experience skin damage or problems with their circulatory system, and may have increased risk of getting cancer.

Lead: If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Greene County is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may want to have your water tested.
