Note: Levies cost per \$100,000 is based on the tax year 2022 valuation. Levies approved in the November 2023 election will be subject to a reduction factor that will reduce the effective tax rate so the levy generates the amount of revenue estimated under "Annual Proceeds Estimated". This means the 2023 valuation increases will result is a reduction in the tax rate. It does not mean the levy will generate more money and thus cause taxpayers more due to the valuation increase.
