If using the Court Assessor to conduct the mandatory Home Study (excluding adult and foreign adoptions), an additional \$750.00 is due at the time of filing for one child being adopted. If there are additional children, add \$50.00 for each additional child.

Placement \$ 1683.00

This fee includes all necessary home study assessments. Placements are arranged by attorneys, and are very rare. Contact the Court for more details reading placement proceedings.
